Freedom of Information Act Statement

Chairman Latiff called the meeting to order and asked Richard Hutto to read into the record the Freedom of Information Statement.

Adoption of Proposed Agenda

Chairman Latiff asked if there were any changes to the proposed agenda. There being none, the Chairman called for a motion to approve the agenda.

MOTION

Commissioner Fleshman moved to adopt the agenda as presented. The motion received a second from Commissioner Haslinger. There being no discussion, all Commissioners voted in the affirmative and the motion carried.

Minutes

The Chairman asked if there were any additions or corrections to the minutes of June 18, 2025. There being none, he called for a motion to approve the minutes.

MOTION

Commissioner Mackie moved to approve the minutes of June 18, 2025, as presented. The motion received a second from Commissioner Fleshman. There being no discussion, all Commissioners voted in the affirmative and the motion carried.

Mortgage Revenue Bonds (MRB) 2025B Pricing Review

Chairman Latiff called on Raymond High, with Bank of America, for a presentation of the recent MRB 2025B transaction. He gave a comprehensive summation of the issuance, which included a financing overview.

The Board accepted the report as information.

Program Committee

Consideration of the Made It Home! Program

The Chairman gave a passionate statement about the housing crisis that is affecting people across not only the state of South Carolina, but across the nation. He proudly shared that SC Housing Staff had worked diligently on a new workforce housing program for homebuyers that will work with qualified home builders to build single family homes. Chairman Latiff asked Steve Clements to provide an overview of the program information and stated that staff recommended approval of the program.

Chairman Latiff asked if there were any questions. After some discussion, the Chairman called for a motion to approve the Made It Home! Program.

MOTION

Commissioner Fleshman moved to approve the Made It Home! Program. The motion received a second from Commissioner Haslinger. There being no further discussion, all Commissioners voted in the affirmative and the motion carried.

Audit and Finance Committee

Consideration of the FY2027 Budget

The Chairman called on Robert Macdonald for consideration of the FY 2027 Budget. Mr. Macdonald presented the proposed FY 2027 State Spend Authority Budget and indicated it is more expense focused than revenue and provided a brief overview.

Chairman Latiff asked if there were any questions. There being no questions, the Chairman called for a motion to approve the FY 2027 Budget.

MOTION

Commissioner Fleshman moved to approve the Fiscal Year 2027 Budget. The motion received a second from Commissioner Haslinger. There being no discussion, all Commissioners voted in the affirmative and the motion carried.

Reports

Homeownership Report

The Chairman asked Mr. Clements to provide the Homeownership update. Mr. Clements provided an update on Single Family Programs to include a snapshot of the change in housing inventory over the last eight (8) years, along with an update on FY25 totals in the Single Family Programs.

The Board accepted the report as information.

Communications Report

Chairman Latiff invited Ana Garcia and Clayton Ingram to the table to share an update from Communications. Ms. Garcia and Mr. Ingram provided a brief overview of updated Economic Impact data that is now available on the SC Housing website under Reports and Publications. They shared that this information will be available to share with the public to include legislators, media, non-profits, customers, etc.

The Board accepted this report as information.

Chairman

Chairman Latiff gave a brief report. The Chairman reiterated the importance of deadlines that have been established in the SC Housing Programs and asked that developers and program participants adhere to these deadlines. He went on to add that while requests for extending deadlines will be heard by the Board of Commissioners, there is no guarantee that an extension will be approved. He then asked Director Hutto provide his report.

Executive Director

Mr. Hutto's report provided encouragement to the Board of Commissioners to build relationships with housing authorities across the nation. He went on to provide additional information in regards to the MRB 2025B Pricing Review provided by Mr. High, along with history on how these programs have developed over the years. He then provided additional information on the Economic Impact Report provided by Ms. Garcia and Mr. Ingram. He thanked the staff for the support they have provided to him over the last few weeks especially; the workforce housing team for all their hard work – to include members of the Board; and the Board members for their engagement with the agency. He finalized his report by sharing the hard work that the Finance Team has done in the work that has been done on the FY25 Audit process.

The Chairman asked if there was any other new business or comments for discussion.

Adjournment

There being no additional business to come before the Board, Chairman Latiff called for a motion to adjourn the meeting.

Chairman Mackie moved to adjourn the meeting. The motion received a second from Commissioner Haslinger. All Commissioners voted in the affirmative and the motion carried.
