## Explanation of any unspent funds (to be provided only if unspent funds remain at the end of the fiscal year):

We have a remaining balance of \$47,522.57 in the Operating Cost Category. This will be expended by the end of August 2025. The reason for the remaining balance is related to the slightly delayed receipt date of the funding. There is a remaining balance of \$359,2552,16 in the New Shelter Construction Cost Category. This is also in part due to the delay in the receipt of funds. It has also been impacted by the timing of contractor invoice submission and the construction timeline. We anticipate the completion of construction by the end of September 2025. However, the state funding allocation should be expended by late
