## Please explain how these funds will be used to provide a public benefit:

The SC Direct appropriations funding will build on previous foundation funding and finalize the establishment of the Parish House Community Development Corporation (CDC).

The Parish House CDC is the entity responsible for implementing the Newtown Master

Plan. To make this a reality, consultants and administrative staff must be funded.

Parish House will be an established CDC in the first quarter of 2025. We are finalizing the

bylaws and essential documentation for making Parish House a legal entity. I anticipate

selecting Board Members and conducting business as Parish House CDC by March 2025.

Board Members will approve all proposed Parish House positions and its operational and capital budgets. The Board will also provide additional oversight guidance to the organization's mission and commitment to the community. With the assistance of professionals, Parish House CDC will update its master plan in the second quarter of 2025. This will include updated property acquisition priorities and a political strategy associated with creating public-private partnerships that will serve as the economic engine to sustain Parish House CDC financially. This will require seeking the appropriate approvals from the City of Greenville and the County of
