Thank you for applying for an Employer Identification Number (EIN). We assigned you EIN 39-2665189. This EIN will identify you, your business accounts, tax returns, and documents, even if you have no employees. Please keep this notice in your permanent records.

The LLC will be treated as a corporation as of the effective date of the S corporation election and does not need to file Form 8832.
