Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

A new HCVP Processing and Reporting Manager was hired July 1, 2025, to manage all aspects of the HCVP Specialists and Financial Analysts. The Director, HCVP Operations became the HCVP Inspections Manager on April 17, 2025, to manage all aspects of the HCVP Inspectors. The HCVP Specialists are now responsible for the complete administration of their case files from conception to termination, which includes conducting briefings and issuing vouchers for new participants and movers; determining initial and continued eligibility for applicants and residents for the HCVP. Duties include interviewing clients; certifying annual and interim requests; processing rent increase requests; completing data entry; uploading documents into On-Base; advising participants and landlords of program rules and regulations; providing excellent customer service to internal and external customers (via phone, email, and in-person); monitoring clients for program compliance; performing rent reasonableness and affordability reviews on all requests for tenancy approval; executing all required HAP contracts; processing cancellations, terminations, and EOPs as necessary; processing files for those porting out of the agency portfolio and porting into the agency; reviewing all files for completeness and accuracy by applying established laws, regulations, policies, and procedures; accessing HUD and related program specific databases to obtain or transmit applicant and participant information; promoting Rent Café and electronic landlord enrollment. A HCVP Financial Department was created. The Financial Analysts are responsible for maintaining financial oversight, compliance, and program performance of the HCVP. Duties include timely VMS submissions including prior month corrections via HUD's Secure System website; compiling and ensuring accuracy of program data prior to submission; processing monthly HAP and URP payments as required; researching and reconciling discrepancies noted and following through to resolution; providing financial data and reports as requested by internal and external clients; weekly PIC submissions to HUD which includes monitoring warning messages and fatal errors to ensure resolution; managing all port-in and port-out payments; managing debts, repayment agreements and debt setoffs as required; coordinating vendor set-up for payments that include providing guidance on landlord registrations/updates and direct deposits; collecting W-9 forms; and coordinating efforts to prepare agency Annual Plans and Administrative Plans. The HCVP Inspectors are now responsible for performing all required HCVP inspections on time all of the time, which includes scheduling and rescheduling inspections with applicants/tenants and landlords; performing initial inspections, special inspections, and re-inspections for properties with deficiencies; abatements; working hand-in-hand with the HCVP Specialists for obtaining required documents from landlords and tenants; documenting the results of all inspections; and transmitting certain inspections to PIC.</p>

SC Housing Development Department has utilized its programs/funding to build new tax credit property/affordable housing in the SC Housing HCV jurisdiction: Peaks of Lexington grand opening 10/2025. Continued partnership with Home Grants to provide security deposit assistance for new applicants. Continued to promote Homeownership Voucher program in partnership with the SC Housing Mortgage Production team to create outreach opportunities targeted at both lenders and realtors throughout the state. We have added 3 new homeownership participants to our program. Continued to utilize special funding from HUD to assist additional families: VASH, Mainstream, EHV and Stability vouchers Promoted a Landlord Liaison to improve Agency/landlord relations. Two outreach events are held quarterly both in-person and virtually to update current landlords on changes and educate prospective landlords on the HCV benefits and obligations. Promoted a Voucher Specialist Trainor to provide updated, interactive training and streamline on-boarding of new employees. Procured Aspire University, a software training module to document procedural progress. Partnering with HR project to improve internal training processes. Quality Control/Data Integrity—Hired a new team of quality control staff independent of the HCV program to conduct monthly audits of HCV files. We had a successful HUD VMS remote review resulting in no findings. Maintained a strong partnership with the South Carolina Department of Health and Human Services through a Memorandum of Understanding to assist with the implementation and administration of a rental subsidy program, which includes case management services, to assist those families that might not otherwise be capable of living independently. Achieve SEMAP High Performer rating - Consistently exceeded HUD's 95% family record reporting requirement, maintaining an average reporting rate of 100%. Restructured department to create an HQS inspection team to provide consistent and timely inspections-/re-inspections.

A. PHA Information.
